

Sterling corporate bonds now offer value against other assets

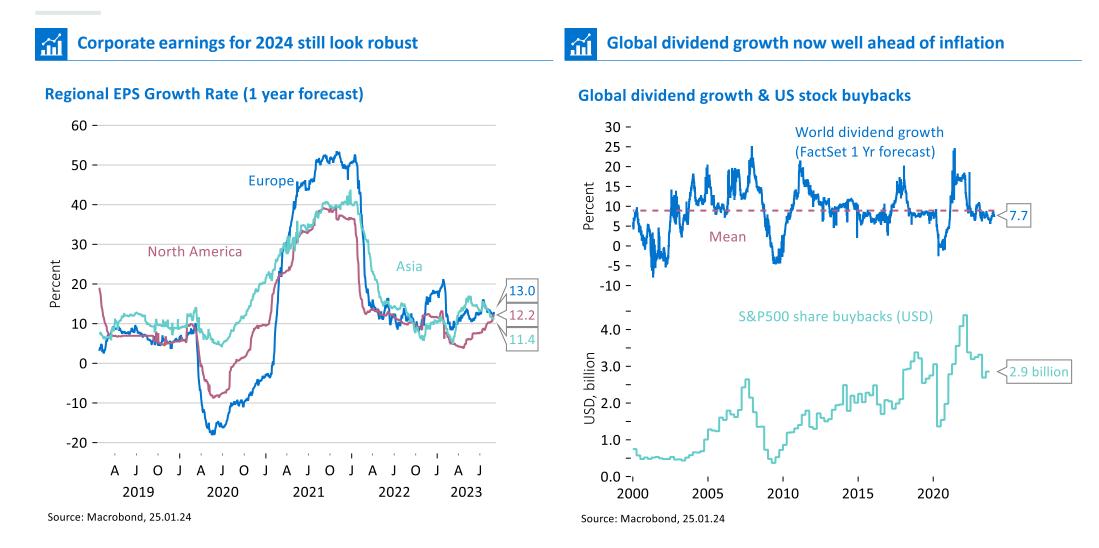




Higher earnings underpinning Growth stock prices




Infrastructure & buildings, low carbon power, resource efficiency & high carbon transition


